DESCRIPTION AND DESIGNATION OF THE PRODUCT

Electric motorcycle **DYNO^M** is completely manufactured in the Czech Republic. It is equipped with a controller that allows you to change the three performance maps of the engine. The current capacity and battery voltage are displayed on a digital indicator in the driver's field of view. The motorcycle is started with the central button. The battery is equipped with control and protection elements. The drive is equipped with a communication and diagnostic interface with the possibility of remote access. The motorcycle can recover electrical energy during engine braking. The recuperation rate is programmable. The powerful motor is equipped with durable bearings, seals and binders. The drive system as a whole is very durable and efficient. The motorcycle has a comfortable enduro saddle and quality off-road tires.

Electric motorcycle **DYNO^M** does not comply with the MD Decree No. 341/2002 and with the European standard EN15194 and it is not possible to operate it on public roads. It is intended only for off-road use on unpaved surfaces and for off-road driving.

Electric motorcycle **DYNO^M** user is obliged to follow all safety instructions given in the electric motorcycle **DYNO^M** technical manual.
